Rules

Referees

1. All games will be refereed.
2. All decisions made by referees are final. Only questions about rule interpretation may be clarified by rule officials.
3. Will be using IHSA rules, except with the following changes.
4. Referees may eject players for continual misconduct or flagrant fouling. Misconduct includes improper behavior such as foul language, obscene gestures, and any disrespect for other players or spectators.
5. A flagrant foul that is called by the referee will result in two free throws being issued to the offended team and they will receive the basketball .
6. When a player is in the act of shooting, 1 free throw is awarded, unless behind the 17 ft. arch, then two shots will be awarded. The ball will be played off the rim.
7. The 1st through 6th common team fouls, results in loss of possession of the ball. On the 7th common team foul, the opposing team will be awarded 1 free throw . The ball will be off of rim.
8. Referees have the authority to bench players for disciplinary purposes. The player sets out until the opposing team scores 2 points.

9. Each individual may only play on one team. The team you register with, will be your team for the duration of the contest.
10. A minimum of 2 players must be present at game time in order to avoid disqualification.
11. Your team will be placed in the age category of the oldest team member.

Scoring (All games start with a 25 minute running clock. Only the last minute can be stopped).

- 10-12 yrs. Men & 10-12 yrs. Women
Play to 13, must win by 2 or first team to reach 16
 - 13-15 yrs. Men & 13-15 yrs. Women
Play to 15, must win by 2 or first team to reach 18
 - 16-18 yrs. Men & 16 +yrs. Women
Play to 18, must win by 2 or first team to reach 21
 - 19-30 yrs. Men
Play to 18, must win by 2 or first team to reach 21
 - 31+ yrs. Men
Play to 15, must win by 2 or first team to reach 18
- *In the event the clock expires before a team reaches the needed points, the team with the most points wins. In a tie the first team to score wins.

The Ball...Dead or Alive

1. Out of bounds first goes to winner of coin toss to start games.
2. Jump ball will go to the defense.
3. The ball must be checked after each dead ball. The ball must be passed in while standing out of bounds at the top of the court, not the take back line.
4. Any ball out-of- bounds must be taken out at the top of the court
5. Top of the backboard is out - of -bounds; sides and bottom are not, at referee's discretion.
6. Ball must be taken back to the 19 ft. line on every change of possession. Both feet and the ball must be taken back completely behind the line.
7. Violation of the taken back rule only occurs if a basket is made by the team at fault and results in loss of point and possession.
8. Player substitution may be made at any dead ball situation.
9. One time out allowed per game, per team and can only stop the clock in the last minute or at referee's discretion.
